Thoughtful, helpful, instructive, gentle: Register now for the next monthly Critiques with Care session



Professional artists brought projects that had stumped them, a neophyte artist sought style and technique coaching. The feedback, guided by MAAA's masterful teacher/artist, was insightful, astute, wide-ranging and always encouraging. Media covered the gamut, including oil, pastel, watercolor and pen & ink, and styles ranged from illustrative to realistic.

Minutes from Spring Meeting held Saturday, March 16 at Hannah Grimes

The MAAA Spring meeting was held at the Hannah Grimes Center from 10am -12 noon on Saturday, March 16, 2024 and was well-attended. Among those present were Ruth Sterling, Kevin Whitfield, Gill Truslow, Sue Doyle, Carol Corliss, Liz Winchester-Larson, Jeanne MaguireThieme, Kate and Sue Beetle, Kris Stewart, Gail Shelley, Gary Custer, Phil Bean, Vernon Thornblad, Sue Hum, Michael Torska and several other members and visitors. Around 25 total attended.

Under old business, the minutes of the last meeting were approved. Ruth Sterling (MAAA President) mentioned our 501c3 status and revision to our Pecuniary Benefits Policy for state compliance. Moving forward, MAAA will continue to be run as a business so that members can benefit as artists. A key factor in this organizational culture shift is: Effective 2023 people who provide professional services which are beyond the level of a volunteer will be paid stipends. This is an essential step to help prevent burnout among individuals providing these services.

For new business, effective April 1, the Board will accept Kate Shaffer, VP's resignation for health reasons. Carol Corliss will be appointed as Interim VP for six months. Kris Stewart gave her Treasurer's Report and discussed the current bank account balances, the expenses and profit for Art in the Park, which include \$9,041 and \$2182 for profit. For 2024, the expenses are estimated to be around \$8582 and a \$2641 profit. Another important point is that interest of \$500 will be earned by our CD by the end of July. Also, MAAA currently has three people/businesses who want to sponsor part of Art in the Park and Kris and committee will be making an effort to attract more sponsorships. This way, MAAA earnings will increase.

Kathleen Kennedy, the new Workshop Committee chair, gave her report. Kathleen called on members to give workshops. She posed the question of what is acceptable, only fine arts, or other things, such as stained glass? Participating artists will be charged a fee. The importance of using social media to promote workshops was discussed.

"Emerging" which consisted of two groups led by Jeanne Maguire Thieme and Ruth Sterling. Among the artists who brought their work to share were Gail Shelley, Sue Beetle,

The final segment of the meeting was a presentation by Michael Torska, owner of New England Art Reproductions. He displayed examples of some reproductions he has done for some clients and mentioned that he does reproductions on varied surfaces which include cards and coasters, as well as varied objects. Indian King Framery in Keene is his drop off point for customers. Michael also discussed that he has some other possibilities he has been exploring, such as T-shirts. Gail Shelley mentioned that she had Mike do reproductions on her ceramic and wooden Christmas ornaments and that she had tried other people who offer the same service and found Michael to be the best one.

Refreshments for the Spring Meeting were provided by Hospitality Committee members Kate and Sue Beetle who capitalized on the St. Patrick's Day holiday to offer delicious Irish scones, cupcakes, cheeses and crackers. Gluten-free crackers and fresh fruit added to the spread, offering something for everyone. The consensus was that the refreshments were excellent.
